Tournament Rules

1. Open to all Camden-Suburban USBCWBA members age 50 and over at time of tournament..
2. This is a Handicap Tournament with competition in Singles, Doubles and All Events.
3. The handicap will be **100% of the difference between the entering average of 220 in the singles and 440 in the doubles. The all-events are scratch.**
4. There will be three (3) age classes of competition in Singles and All Events:
Class A = 70 and older, Class B = 60 to 69, and Class C = 50 to 59
5. Doubles partners do not have to be from the same Class group as there is only one class of competition in the doubles event.
6. Entrant can compete only once in this tournament. **Check-in is 45 minutes before squad time.**
7. AVERAGES- CSWBA Book
The following is the order in which averages will be checked :
(A) 2007-2008 Winter Season
(B) 2007 Summer Season
(C) A bowler lacking all of the above data must use an average of 220.
8. An entrant is responsible for verification of the entering average, whether submitted by the bowler or someone else. Failure to use the proper average shall disqualify all scores if submitted average is lower than actual average thereby resulting in more handicap. Prize winnings will be based on the submitted average if it is higher than the actual average. In Doubles the averages will be combined to determine whether the correct total is higher or lower than the submitted total. Corrections in average may be made up to the completion of the first game of a series, or within 48 hours of completion of the series, if, prior to completion of the first game, written consent is given by the ranking tournament official present.
9. No blind Score—Late bowler shall enter play and scoring count beginning with frame being bowled. Zero (0) for all missed frames. Rule 319c and 319d will be waved.
10. Entry fee will not be returned after the closing date of October 17, 2008.
11. Champion doubles with the highest total , including handicap, are eligible to enter the State Senior Tournament with entry fee paid by C S USBC WBA. (Note the state minimum age is 55)
12. All-events is the net total of your 6 games bowled.
