**General Rules**

1. The Camden Suburban USBC WBA Queens Tournament is a USBC WBA handicap event.
2. Total pin fall carries into the Semi-finals.
3. The final round is a step-ladder event (head to head).
4. Entrants should hold a minimum average of 165 or lower for 21 games or more in a USBC certified league for the 2010-11 season, and shall be a member of Camden Suburban USBC WBA.
5. Entrants must report 30 minutes prior to scheduled time. Late bowler rule 322a will prevail.
6. Entrant will be assigned a starting lane.
7. If an entrant is unable to bowl she must notify the tournament manager, who will attempt to make a replacement. After the schedule is prepared no entry fees will be returned.
8. 1st round - will consist of five (5) games bowled across five pairs of lanes.  
 2nd round - will consist of 1/3 of the total entries, who will bowl three (3) games across 3 pair.  
 Final round - top five (5) qualifiers from the second round will bowl a one game elimination.  
 Number 5 matched with Number 4, with the winner meeting Number 3, the winner meeting Number 2, with the winner matched against Number 1 for the title.
9. TIES: in the event of a tie for any round, a 9th and 10th frame roll-off will decide the winner.
10. Entrants are required to wear suitable attire (no short shorts, mini skirts, or tank tops).

The decision of the Tournament Committee shall be final unless an appeal is made in accordance with USBC rule #329
